

Growth rate of investment in the UK's lawtech sector between 2017 and 2022




FRONTIER TECHNOLOGIES (FT) ARE REVOLUTIONIZING OUR WORLD

UNCTAD's *Technology and Innovation Report 2025* states frontier technologies had a **\$2.5 trillion** market in 2023, and that it could increase to **US\$16.4 trillion** by 2033.

The global AI market is currently (2025) valued at about **US\$391 billion**, with projections up to **US\$1.81 trillion** by 2030.
